**SUBJECT: -Extension of General Affiliation up to Senior Secondary Level.**

This is with reference to school application on the subject cited above. In this connection, I am directed to convey the approval of the Board for Extension of General Affiliation as per details given below:-

<b>Sl. No.</b>	<b>The school is directed to ensure that :</b>
1	The total number of sections of the school shall be restricted to 18 of which not more than 1/3rd sections may be used for senior secondary classes. Number of the students shall be restricted to 32 in 16 sections, (as per dimension). Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law subject to availability of class rooms of greater than 500 ft dimension
2	Height of the boundary wall is less than 6 ft, as it is partly covered with the Iron grill. The school is directed to raise the height of the concrete boundary wall upto minimum 6 ft from all sides within 03 months and submit videography link covering the complete boundary wall from all sides in continuity along with aerial view in the compliance.
3	The school is required to construct the ramp at the main entrance of school building and ramp/lift to access upper floors as per PRwD Act and Board's Guidelines within 03 months and submit the compliance.
4	The school has constructed the CwsN toilet at ground level. However, ramp connected to girls CwsN toilets is uneven from the ground level and there is no proper space to enter in CwsN boys toilets. Thus, the school is required to construct the separate toilets for CWSN girls and boys on each floor with proper infrastructural facilities in accordance with the provisions laid down in RPWD and Board's Guidelines within 03 months and submit the compliance.
5	The school is required to obtain the renewed / permanent recognition certificate within 3 months and submit the compliance.
6	The school shall conduct training of its teachers with CoE Noida within 3 months and submit the compliance

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school is required to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
